Child Development (Birth to 5) Education & Coaching, Family Engagement, Mental Health, and Support Infant/Early Childhood Professionals who are planning to become Reflective Supervisors/Consultants

This specialized training series, offered in partnership with the Florida Association for Infant Mental Health (FAIMH), is designed for Head Start and Early Head Start professionals in supervisory roles who are seeking to strengthen their skills in reflective supervision. Participants who enroll in this track will complete 7.5 hours of training—six hours in person on October 29th during the FHSA Annual Conference, plus a required 90-minute virtual session on November 13th from 3:30–5:00 PM. Completion of this series fulfills half of the training hours needed to become an Endorsed Reflective Supervisor in Florida.
